The following table identifies Child Support Enforcement Network (CSENet) Function, Action, Reason (FAR) code combinations

• The Include Systemic Provides radio button defaults to "No". Systemic Provides are communications automatically triggered as a result of database updates. When Errors are returned from the CSENet Hub, the worker must correct the data conflict, then navigate to the Send Interstate Correspondence page and click on the "Yes" radio button to "Include Systemic Provides" to regenerate the errored communication.
