The following table identifies the tasks received on an intergovernmental case and the actions required in order to resolve the task and remove from the Manage Tasks page.

Received - Acknowledgment - Additional Info Needed

Interstate Transmittal received on ICOR. Communicate with other state to determine what information is requested. Review case and send information that the other state is requesting. Then send ISND transmittal.

• Received - Request Current Status

Interstate Transmittal received on ICOR. Other state has requested Current Status. Must respond via ISND.

The other state is sending you a reminder that attachments to your initial Enforcement Request are Overdue. Communicate with other state to determine what information is requested. Review case and send information that the other state is requesting. Then send ISND transmittal.

• Received - Request support order modification

ICOR transmittal received from the other state requesting a modification. However, NJ is a judicial state and the other state must submit a completed UIFSA petition to the ICR. Communicate to the other state's caseworker to let them know what is needed. Send ISND message requesting additional information to Proceed.
